Although this road is on the county map, it is not a road that is maintained by the county as it is only an access road to their property and not a public access road. The Commissioners wrote a letter explaining this.

Resident Rori Seidlitz was in to ask about support maintaining a private road if he were to purchase and haul the gravel. He asked if the county could just spread the gravel for him. The Commissioners explained that in addition to not having the manpower available, the high cost of fuel and labor would prohibit the road department from being able to provide this service for individuals.

OPIOID CRISIS SETTLEMENT FUNDS

County Attorney Robert Padmos explained more details about the Opioid Crisis Settlement funds that the State of Montana is receiving and distributing to Montana counties. Liberty County will not be awarded enough funds to justify the time it takes to fill out all the paperwork required. They discussed returning the money to the state for reallocation.
